- I will represent my team with respect both on and off the court.
- I will strive to be at every practice and game.
- I will do my very best to listen and learn from my coaches.
- I will treat my coaches, other players, officials and fans with respect regardless of race, sex, creed, or abilities and I will expect to be treated the same.
- I will not use profanity or "trash talk" my opponents.
- I will not use violence to handle conflicts.
- I will notify parents and coaches if my sports activity stops being fun.

## PARENT CODE OF CONDUCT

By signing this pledge, I commit to be positive about my player's youth sports experience and accept responsibility for my participation in my player's sport, as well as my player's actions, by following the Parent's Code of Conduct:

- I will encourage good sportsmanship by demonstrating positive support of all players, coaches, and officials at every game, practice or other youth sports events.

- I will place the emotional and physical wellbeing of my player ahead of my personal desire to win.

### Waiver, Release from Liability, and Indemnity Agreement

1. I agree that I am voluntarily participating in these activities and using these facilities and premises and assume all risk of injury to myself or the contraction of any illness or medical condition that might result, or any damage, loss or theft of any personal property.
2. I agree on behalf of myself (and my personal representatives, heirs, executors, administrators, agents and assigns) to release and discharge Lee Road (and its affiliates, employees, agents, representatives, successors and assigns) from any and all claims or causes of action (known or unknown) arising out of Lee Road's negligence. This Waiver and Release of liability includes, without limitation, injuries which may occur as a result of: (a) my use of any exercise equipment or facilities which may malfunction or break; (b) Lee Road's improper maintenance of any exercise equipment or facilities; (c) Lee Road's negligent instruction or supervision; and (d) my slipping and falling while in the facility or on the premises.

I agree that in the unfortunate event that I am injured or become ill while participating in any activity at the facility, on Lee Road premises, or any off campus trip, that I will hold Lee Road and any of its agents harmless. I further authorize Lee Road representative(s) and any attending medical personnel, should I be unable to make a decision, to perform medical treatments and/or procedures upon, myself as they deem necessary and proper under the circumstances. I agree to indemnify and to hold harmless Lee Road, its representatives or attending medical personnel, from any and all actions, related risks and dangers, including negligence damages, and liabilities arising out of the treatment of any sickness or injury. I also agree to assume full financial responsibility for all medical treatment.
4. I give my permission and consent to Lee Road for any photographs, videotapes and interviews to be taken during FLC or recreation activities/events to be published and used to illustrate, report, and advertise our ministries including on Internet Web Site promoting or reporting on our church.
